COURSE DESCRIPTION: In addition to familiarizing participants with the rigorous content and recent developments of residential applications covered in the new qualifying education courses required by the AQB, participants will apply market analysis and highest and best use concepts and procedures to residential examples and problems. A self-assessment at the end of the day evaluates appraisal strengths as well as determines skill areas in which to seek further knowledge.

COURSE INSTRUCTOR: Kenneth G. Foltz, MAI, SRA

REQUIRED EQUIPMENT: An HP12C calculator is required for this course. Attendees must be familiar with its operation before the course begins. Answers to problems in course material are shown using the HP12C. ***Do not come to class expecting to be taught how to use a financial calculator.***

ENROLLMENT: Enrollment is on a first-come, first served basis. If the event is filled, a waiting list will be retained. The San Diego Chapter reserves the rights to cancel, limit, or reschedule this event if the minimum enrollment level is not reached, and to change faculty assignments and facility locations at any time.
